Direct Deposit for your 2016 Tax Refund

If you are expecting a refund when you file your federal income taxes, it's easy to directly deposit these funds into your credit union checking or savings account, and it's **FREE!**

According to the IRS, a refund check is issued within 6-8 weeks of filing a paper return, or 3 weeks for E-Filing. However, if you choose to E-File **AND** direct deposit, the you should receive it within **14 days!** Direct deposit is safer, easier, and faster. To direct deposit your refund, go to the "Refund" portion of your tax return:

- Enter MFCU's Routing number: **291479615**
- Select Account type: Checking or Savings
- Enter your **checking** or **savings** account number
- For **Checking** accounts, use the full account number located on the bottom of your checks.

EMV CHIP ENABLED CARD TO GO LIVE!

1. What makes chip cards so secure?

The card produces a one-time transaction code each time you buy something. The retailer doesn't know your actual account or card number and it can't be hacked or stolen later from their system.

2. Can a thief can my card as I walk by and steal my information?

EMV chip cards are not RFID (radio frequency identification cards). That means they do not emit a radio wave that could be stolen by a criminal with a cards scanner.

REMOTE DEPOSIT CAPTURE

MFCU has implemented an additional service to offer you very soon.

If you can't make it to the credit union to deposit a check into your account, ask us and you may be eligible to add this feature to your mobile device.
